COURSE FEES

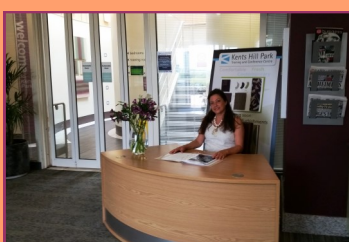
While there is no closing date for applications, **early bookings are advised** as places are allocated on a 'first come, first served' basis. Unplaced applicants will be put on a waiting list.

ACCOMMODATION FOR THE IN PERSON COURSES

The fees shown above for 1.5 day, 1.8 day and 2 day in person courses **include** 1 night's accommodation, with lunch, dinner and breakfast. If no accommodation is required, the course fee will be reduced by £100+VAT for each relevant night. If accommodation is required for the night before or after an in person course, this can be reserved: the additional cost is £100+VAT in the case of dinner, bed and breakfast, or £75+VAT for bed and breakfast.

Where accommodation (with meals) is **between** consecutive in person courses the extra cost is **£75+VAT**.

SPECIAL OFFERS

We offer a **discount of 5%** on course fees for firms which book **five places/courses or more**.

For those taking **all five Foundation Certificate courses** (with accommodation also on 5 July), we offer a special package rate, after all discounts, of **£3,300+VAT**: this represents a saving of £375+VAT (i.e. a discount of >10%).

NOTES ON SPECIFIC COURSES

▲ The 22/S and 22/T I&V FD4 'split course' is geared towards those taking FD4 for the first time and who would like to attend an introductory Day 1 in mid-May, which provides guidance and initial practice on how to approach FD4 paper followed by a further 1.5 days, in late July, which will cover in more detail key aspects of the paper, along with practice of the learning so far. You will be asked to do a past paper after Day 1, receiving feedback, and a further paper after Part 2. There will be a 2-hour Zoom meeting in September to discuss the recent paper tackled and for any further queries. The split course provides a more gradual and thorough introduction to FD4 than the more intensive 2-day courses.

▲▲ These courses have higher fees as a feature is tutor review and feedback on a past paper you will be asked to attempt before or after the course.

▲▲▲ The FD4 re-sitter course includes tutor feedback on your 2021 exam script plus tutor review and feedback on a past paper you will be asked to attempt after the course. For re-sitters who have attended a JDD FD4/P6 course in 2021 or earlier, the fee is reduced by £50+VAT to £400+VAT. The course is recommended those who have failed FD4 twice or more. For those who have failed only once, it is better to attend one of the FD4 2-day courses

◆ The 22/F-H courses with Scott Goodall and Ali Lee are being held virtually, using Zoom, with the number on each course limited to 11 to enable a high level of interaction. The tutoring time on each course will be 1.5 days.
