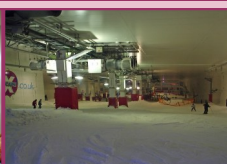
Will be sent to course members 3-4 weeks before the start of each course, together with a course programme and details of any pre-course work.

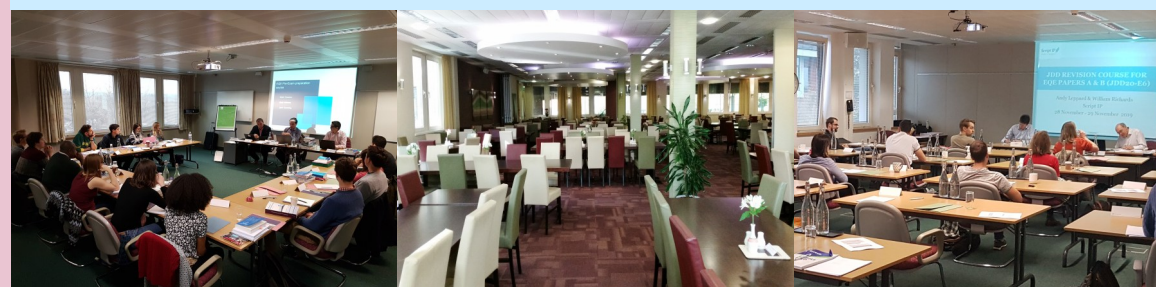
